## ORDINANCE NO. 2021-62

OFFICIALLY NAMING THE STREETS IN BARANGAY MAINIT, CITY OF NAGA, CEBU AS FOLLOWS: 1. FROM FOOTBRIDGE TOWARDS PUROK CENTER 1 AS DOMINADOR PATALINGHUG STREET; ADJACENT TO THE BARANGAY HALL TOWARDS MAINIT ELEMENTARY AND NATIONAL HIGH SCHOOLS AS MODESTO SAYSON STREET; FROM BARANGAY HALL TOWARDS SITIO GRAYROCKS OF BARANGAY PANGDAN AS GONZALO CANOMON STREET; FROM SITIO GRAYROCKS TOWARDS SITIO UG-UG CHAPEL AS CONSTANCIO PANILAG STREET; AND BARANGAY ROAD OF SITIO TAL-OT AS ANTONIO **CANQUE STREET** 

## **EXPLANATORY NOTE**

Section 13 (c) of Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991. states that the Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, rename within its territorial jurisdiction city roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of Mainit passed Resolution No. 15, series of 2021 dated April 19, 2021 formally endorsing to the City Council of the City of Naga, Cebu the naming of the identified streets as stated in the title of this proposed ordinance.

The Sangguniang Barangay deems it appropriate to name the existing streets in honor of the individuals for their invaluable contributions to the progress and development of Barangay Mainit, City of Naga, Cebu, namely:

- > DOMINADOR PATALINGHUG. He was known for his generosity with good standing in the community. Out of his kindness and determination to help the residents, Mr. Patalinghug donated a lot for the construction of a barangay road in Mainit. At present, the road serves as an important access in the community.
- MODESTO LESCANO SAYSON. He was a volunteer teacher in Barangay Mainit and served as town councilor of the then Municipality of Naga, Cebu from 1952 to 1959 under the administration of Naga Municipal Mayor Reynaldo Mendiola. Through his initiative, he was able to persuade a couple to donate their property for the construction of a school building. The generous couple then donated a big parcel of land where buildings for elementary and high schools currently stand. He passed away at the age of 90.

- CONSTANCIO SAYSON PANILAG. He served as barangay captain of Mainit from 1982 to 1986 and maintained his simplicity, humility and honesty in public service. In his term, Tancio, as he was fondly called in the village, spearheaded the enactment of local measures, organized community programs and facilitated the delivery of basic services despite the lack of government funds. He demonstrated good leadership by imposing honest and effective governance and ensuring peace and order and cleanliness in the barangay. Though he was replaced after the 1986 EDSA revolution, he was still elected and served as barangay kagawad from 2000 to 2003.
- ➢ GONZALO SAYSON CANOMON. A Tenyente del Barrio for ten years from 1968 to 1978, he dedicated his life to serving his constituents with honesty and good faith. He efficiently acted as a channel between his people and ranking government officials with the objective of providing the basic needs of local residents. The Canomons were considered as family of public servants because Mr. Canomon's wife, Andrea served as the second Tenyente del Barrio from 1978 to 1986, while his youngest son, George and his granddaughter, Violeta were elected as barangay councilors, respectively.
- ➤ ANTONIO HEREDIANO CANQUE. Like Mr. Patalinghug, Mr. Canque was remembered for his being a good citizen of Mainit. He donated a parcel of land for the establishment of a health center. His eldest son, Lauro, Sr. was elected as kagawad and served the barangay from 1999 to 2002. Mr. Canque's grandson, Marknel was also elected as barangay kagawad in 2018.

This August Body, in a session duly assembled, deemed it proper to recognize and give honor to the abovementioned well-meaning and civic-minded individuals who, during their time as public servants or in their own private capacity, have immensely contributed to the socioeoconomic development of Barangay Mainit.

**BE IT ORDAINED**, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the official naming of:

- a) DOMINADOR PATALINGHUG STREET;
- b) MODESTO SAYSON STREET;
- c) CONSTANCIO PANILAG STREET;
- d) GONZALO CANOMON STREET; AND
- e) ANTONIO CANQUE STREET
- in Barangay Mainit, City of Naga, Cebu.

SECTION 2. OFFICIAL STREET NAMES. This Ordinance hereby declares that Dominador Patalinghug, Modesto Sayson, Constancio Panilag, Gonzalo Canomon, and Antonio Canque be used as the official street names in Barangay Mainit and in all official transactions in the City of Naga, Cebu.

**SECTION 3. COVERAGE.** For the sole purpose of this Ordinance, the Office of the City Planning and Development Coordinator, the City Engineer's Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of the abovementioned streets.

**SECTION 4. FUNDS AND IMPLEMENTATION.** The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of signage for proper guidance and direction of pedestrians, motorists and the riding public.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.
