RETITLING THE PLANTILLA POSITION OF POPULATION PROGRAM WORKER TO POPULATION PROGRAM WORKER I UNDER THE OFFICE OF THE CITY POPULATION DEVELOPMENT OFFICER OF THE CITY OF NAGA, CEBU

EXPLANATORY NOTE

On November 11, 2020, the 4th Sangguniang Panlungsod (SP) enacted Ordinance No. 2020-48, titled: "CREATING CAREER AND NON-CAREER POSITIONS IN THIS LOCAL GOVERNMENT UNIT IN THE OFFICES OF THE CITY MAYOR, CITY ADMINISTRATOR, CITY LEGAL, CITY GENERAL SERVICES, CITY SOCIAL WELFARE & DEVELOPMENT, CITY HEALTH, CITY POPULATION DEVELOPMENT, CITY INFORMATION & COMMUNITY RELATIONS DEPARTMENT AND CITY **ENVIRONMENT & NATURAL RESOURCES."**

The enactment of the Ordinance led to the creation of several plantilla positions in the abovementioned City Government offices, which include Population Program Worker under Item No. 7621-2 of the Office of the City Population Development Officer.

The City Government recognizes the need to create these new positions to augment the workforce in the respective offices and ensure continuity of the established programs, projects and activities of this local government unit.

The Office of the City Human Resource Division, headed by Ms. Grace S. Marquez, HRMO IV, requested this Sanggunian to change the present title position of Population Program Worker to Population Program Worker I to satisfactorily comply with the finding stated under Resolution No. 383-2021 of the Sangguniang Panlalawigan of Cebu.

"In this case, the newly created positions conform with the Budget Circular No. 2018-4 dated October 16, 2018 and Budget Circular No. 2020-4 issued on July 17, 2020, except the position of Population Program Worker. Accordingly, the proper position title which should have been created is Population Program Worker 1. Nevertheless, this Committee holds that the present referral is proper and in order," read Resolution No. 383-2021.

The same Resolution reminded this August Body that the "creation of the subject Positions shall not exceed the budgetary limitation on personal services of the City in compliance with Section 325(a) of the Local Government Code of 1991."

ORDINANCE NO. 2021-64 RETITANG RLANTILLA POSITION



BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. TITLE - This ordinance shall be known as "RETITLING THE PLANTILLA POSITION OF POPULATION PROGRAM WORKER TO POPULATION PROGRAM WORKER I UNDER THE OFFICE OF THE CITY POPULATION DEVELOPMENT OFFICER OF THE CITY OF NAGA, CEBU."

SECTION 2. RETITLING - There is hereby modification of the plantilla position to conform with the observation of the Sangguniang Panlalawigan of Cebu as stated under Resolution No. 383-2021, more particularly described as follows:

SECTION 3. STAFFING PATTERN - With the retitling of the position mentioned in the immediately preceding section, the staffing pattern of the above-stated office is hereby modified accordingly.

SECTION 4. APPROPRIATION - The City Government of Naga, Cebu shall appropriate the necessary funds in its annual budget to cover the salary and other benefits of the employee who will be appointed to the above-stated position.

SECTION 5. **SEPARABILITY CLAUSE** - should any provisions of this Ordinance be declared illegal or unconstitutional by any court of competent jurisdiction, those not so declared shall remain in full force and effect thereof.

SECTION 6. REPEALING CLAUSE - Any other ordinance or parts thereof inconsistent with this enactment is hereby repealed or amended accordingly.

SECTION 7. COPY FURNISHED - The Office of the City Mayor, the Civil Service Commission, City Budget Office and the City Human Resource Division shall be furnished copies of this Ordinance for their information, reference, documentation and appropriate action.

SECTION 8. EFFECTIVITY - This ordinance shall take effect immediately upon approval in accordance with law.
