**ORDINANCE NO. 2021-65**

**APPROVING THE NAMING OF FIVE (5) STREETS IN BARANGAY BAIRAN, CITY OF NAGA, CEBU AS FOLLOWS: SAN ROQUE STREET, IGLESIA STREET, SAN ISIDRO STREET, RODRIGO "EGONG" ZABATE STREET, AND PEDRO DEDUMO STREET**

Republic Act No. 7160, otherwise known as "the Local Government Code of 1991", specifically Section 13, paragraph (c), empowers the Sanggunian, in consultation with National Historical Commission, to change the name of city, municipal, and barangay roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of Bairan, City of Naga, Cebu forwarded to this Sanggunian Resolution No. 60A, Series of 2021 approved on March 8, 2020, endorsing the naming of five (5) streets traversing seven (7) Puroks, namely: Purok 7-Lanzones, Purok 6-Avocado, Purok 5-Caimito, Purok-4 Nangka, Purok 3-Mangga, Purok 2-Tambis and Purok 1 Sambag.

The Sangguniang Barangay deemed it appropriate to name the existing yet unnamed streets in the barangay, and with the consensus of the local residents, who interposed no objection during the March 09, 2020 public hearing, that these streets be named as follows:

- Purok 7-Lanzones, Purok 8-Avocado and Purok 5-Caimito as San Roque Street;
- Purok 4-Nangka as Iglesia Street;
- Purok 3-Mangga, Purok 2-Tambis and Purok 1-Sambag as San Isidro Street;
- Purok 2-Tambis (other road) as Rodrigo "Egong" Zabate Street; and
- Purok 5-Caimito (other road) as Pedro Dedumo Street.

Attached in the Minutes of Resolution 60A, Series of 2021 is the rationale justifying the naming of these streets more particularly described hereunder, as follows:

- **San Roque Street** – residents unanimously agreed that the street traversing Purok 7-Lanzones, Purok 8-Avocado and Purok 5-Caimito be named as San Roque (St. Roch) in honor of this most revered 14<sup>th</sup>-century saint of the Roman Catholic Church;

- **Iglesia Street** - Residents reached a consensus that the street passing through Purok-4 Nangka be named as Iglesia as majority of the dwellers in the area are members of the Iglesia ni Cristo (INC), an independent nontrinitarian Christian church, founded and registered by Felix Y. Manalo in 1914. (source Wikipedia);
- **San Isidro Street** - this refers to the revered St. Isidore, known as the patron saint of farmers of the Roman Catholic Church. The residents agreed to name the street traversing Purok 3-Mangga, Purok 2-Tambis and Purok 1-Sambag in honor of St. Isidore, the barangay's second patron saint;
- **Rodrigo "Egong" Zabate Street** - this refers to the late Mr. Rodrigo Zabate or locally known as Egong in the community. Residents found it fitting to name the street in Purok 2-Tambis (other road) in his honor being the pioneering resident in the place; and
- **Pedro Dedumo Street** - Majority of the residents of Purok-5 Caimito (other road) are the Dedumos, who include Mr. Pedro Dedumo, a well-known personality with good reputation in the community. Thus, the barangay deemed it appropriate to name the street in the other road of Purok 5-Caimito in honor and memory of Mr. Dedumo.

**BE IT ORDAINED**, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in session assembled, that:

**SECTION 1. TITLE.** This Ordinance shall be known as the official naming of:

- Purok 7-Lanzones, Purok 8-Avocado and Purok 5-Caimito as **SAN ROQUE STREET**;
- Purok 4-Nangka as **IGLESIA STREET**;
- Purok 3-Mangga, Purok 2-Tambis and Purok 1-Sambag as **SAN ISIDRO STREET**;
- Purok 2-Tambis (other road) as **RODRIGO "EGONG" ZABATE STREET**; and
- Purok 5-Caimito (other road) as **PEDRO DEDUMO STREET**.  
in Barangay Bairan, City of Naga, Cebu.

**SECTION 2. OFFICIAL STREET NAMES.** This Ordinance hereby declares that the streets enumerated above shall be used as the official street names in Barangay Bairan and in all official transactions in the City of Naga, Cebu.

**SECTION 3. COVERAGE.** For the sole purpose of this Ordinance, the Office of the City Planning and Development Coordinator, the City Engineer's Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of the abovementioned streets.

**SECTION 4. FUNDS AND IMPLEMENTATION.** The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of signage for proper guidance and direction of pedestrians, motorists and the riding public.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.


**SECTION 6. REPEALING CLAUSE.** All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 7. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.




