APPROVING THE NAMING OF STREETS IN BARANGAY COLON, CITY OF NAGA, CEBU AS FOLLOWS: SAN ISIDRO LABRADOR STREET, ROSARIO ALFORQUE STREET, FE DAYRETT STREET, DOMINADOR ALMOCERA STREET, GREGORIO BARICUATRO STREET, NGCP STREET, SAN ROQUE STREET, BRAULIO LAGARAS STREET, UNDERPASS STREET AND EPIFANIO DE GRACIA STREET

Republic Act No. 7160, otherwise known as “the Local Government Code of 1991”, specifically Section 13, paragraph (c), empowers the Sanggunian, in consultation with National Historical Commission, to change the name of city, municipal, and barangay roads, avenues, boulevards, thoroughfares and bridges.

The Sangguniang Barangay of Colon, City of Naga, Cebu forwarded to this Sanggunian Resolution No. 016, Series of 2021 formally endorsing the naming of ten (10) streets that traverse the different puroks in the Barangay.

In a May 05, 2021 public hearing, barangay leaders and residents reached a consensus to establish the above-stated street names more particularly described as follows:

- **San Isidro Labrador Street** - in honor of San Isidro Labrador, the patron saint of Sitio Canhambay at Purok 4-Malaysian Mums;
- **Rosario Alforque Street** - in honor of Rosario Alforque, the former barangay captain, who offered to a open a road-right-of-way at Purok 7-Sunflower to Purok 1-Lithium;
- **Fe Dayrett Street** - named after the lot owner located between Purok 10-Anthurium and Purok 9-Gladiola;
- **Dominador Almocera Street** - named after the lot owner located between Purok 7-Sunflower and Purok 9-Gladiola;
- **NGCP Street** - it stands for National Grid Corporation of the Philippines, which opened an access road located at Purok 18-Yellow and Purok 12-Santan;
- **San Roque Street** - in honor of Sr. San Roque, the patron saint of Sitio Cayam located from Sitio Cayam chapel to Purok 15-American Rose;
- **Braulio Lagaras Street** - named after the lot owner located at Purok 16-African Daisy;

- **Underpass Street** - located beside Colon Barangay Hall leading to Purok 24-Birds of Paradise that runs on top of the barangay's main drainage; and
- **Epifanio De Gracia Street** - named after the lot owner who donated a portion of his property from NGCP Plant to Purok 13-Bougainvillea.

BE IT ORDAINED, as it is hereby **ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as "APPROVING THE NAMING OF SAN ISIDRO LABRADOR STREET, ROSARIO ALFORQUE STREET, FE DAYRETT STREET, DOMINADOR ALMOCERA STREET, GREGORIO BARICUATRO STREET, NGCP STREET, SAN ROQUE STREET, BRAULIO LAGARAS STREET, UNDERPASS STREET AND EPIFANIO DE GRACIA STREET, IN BARANGAY COLON, CITY OF NAGA, CEBU."

SECTION 2. OFFICIAL STREET NAMES. This Ordinance hereby declares that the streets enumerated above shall be used as the official street names in Barangay Colon and in all official transactions in the City of Naga, Cebu.

SECTION 3. COVERAGE. For the sole purpose of this Ordinance, the Office of the City Planning and Development Coordinator, the City Engineering Office and other line agencies of this local government unit shall determine and assess the data, coverage and other technical descriptions of the abovementioned streets.

SECTION 4. FUNDS AND IMPLEMENTATION. The City Government of Naga, Cebu shall appropriate funds for the implementation of this Ordinance, which includes the mandatory putting up of signage for proper guidance and direction of pedestrians, motorists and the riding public.

SECTION 5. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional by any court of competent jurisdiction, the other provisions unaffected shall remain valid and subsisting.


SECTION 6. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
