CREATING NEW CAREER AND NON-CAREER POSITIONS UNDER THE DIFFERENT OFFICES OF THE CITY GOVERNMENT OF NAGA, CEBU EFFECTIVE JANUARY 01, 2022 AND PROVIDING FUNDS THEREOF

EXPLANATORY NOTE

The Sangguniang Panlungsod, as the legislative body of the City, as stated in Article IV, Section 11 (Powers, Duties, Functions and Compensation) of Republic Act 9491 also known as the Charter of the City of Naga, shall enact ordinances, approved resolutions and appropriate funds for the general welfare of the City and its inhabitants pursuant to Section 16 of the Local Government Code and in the proper exercise of the corporate powers of the City as provided for under Section 22 of the Local Government Code, and shall:

"(1)(viii) Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs; projects, services and activities of the city government."

The City Government recognizes the need to continuously upgrade its organizational structure through the creation of new career and non-career positions to achieve efficiency in the delivery of basic services to its constituents.

The creation of these new positions will likewise provide good opportunities for all the qualified rank and file employees, and thereby setting the movement of personnel of various City Hall offices that are covered by this Ordinance.

BE IT ORDAINED, as it is hereby ORDAINED by the Sangguniang Panlungsod of the City of Naga, Cebu, in a session duly assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as "CREATING NEW CAREER AND NON-CAREER POSITIONS UNDER THE DIFFERENT OFFICES OF THE CITY GOVERNMENT OF NAGA, CEBU EFFECTIVE JANUARY 01, 2022, AND PROVIDING **FUNDS THEREOF."**

SECTION 2. DECLARATION OF POLICY. It is the policy of the City Government of Naga, Cebu to create positions paid wholly or mainly from city funds for effective and efficient delivery of basic services.

SECTION 4. ORGANIZATIONAL STRUCTURE. With the creation of these new positions as stated in the preceding section, the respective organizational structures of the above-stated offices are hereby modified accordingly.

SECTION 5. FUNDING/APPROPRIATION. The City Government shall appropriate the necessary funds in its annual budget to cover the salaries and other benefits of the employees who will be appointed to the positions above-mentioned.

SECTION 6. SEPARABILITY CLAUSE. If for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, the other sections or provisions not affected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All ordinances, resolutions, orders, issuances, rules, regulations, or parts thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect on January 01, 2022.
