**AMENDING SECTION 2 OF ORDINANCE NO. 2021-78, ENTITLED: ADOPTING THE MODIFICATION OF NURSE POSITIONS PURSUANT TO DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) BUDGET CIRCULAR NO. 2021-2**

**EXPLANATORY NOTE**

On September 29, 2021, the Sangguniang Panlungsod (SP) enacted the abovementioned Ordinance in compliance with the DBM Budget Circular No. 2021-2, which sets the rules and regulations on the upgrading of the entry-level of Nurse Positions, pursuant to Section 32 of RA No. 9173 or the Philippine Nursing Act of 2002.

The Office of the Secretary to the Sangguniang Panlalawigan furnished this August Body a copy of Resolution No. 2622-2021 (tackled during the Provincial Board's out-of-town regular session on November 29, 2021), containing favorable recommendation of the Committee on Laws and Review on Ordinances, chaired by Hon. Raul D. Bacaltos, for its approval subject to modification of City Ordinance No. 2021-78.

The Committee stated in its report, however, that the City Council of Naga, Cebu may have "inadvertently overlooked" the proper position title of the third nurse position, which is quoted verbatim below:

*"However, the Sangguniang Panlungsod may have inadvertently overlooked the modification of the position attributes of the third nurse position . . . wherein prior to BC No. 2020-4 the same should appear as Nurse III, SG 17 while Nurse II, SG 17 is appropriate conformably with BC No. 2020-4 January 01, 2020, and not Nurse II SG 17 and Nurse II, SG 15, as enacted, respectively."*

In view of the Committee's observation, this Sanggunian deems it appropriate to make the necessary corrections through the enactment of this measure.

**NOW THEREFORE, be it ORDAINED, as it is hereby ORDAINED** by the Sangguniang Panlungsod of the City of Naga, Cebu that:

**SECTION 1. TITLE.** - This Ordinance shall be known as **"AMENDING SECTION 2 OF ORDINANCE NO. 2021-78, ENTITLED: ADOPTING THE MODIFICATION OF NURSE POSITIONS PURSUANT TO DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) BUDGET CIRCULAR NO. 2021-2."**


**SECTION 5. REPEALING CLAUSE.** - Any ordinance or parts thereof inconsistent with this enactment is hereby repealed or amended accordingly.

**SECTION 6. EFFECTIVITY.** - This Ordinance shall take effect immediately upon approval.


