**ORDINANCE NO. 2025-60**

**CONFIRMING THE REVISIONS, CHANGES AND/OR AMENDMENTS OF THE ORIGINAL PROJECTS, PURPOSES AND CORRESPONDING COSTS AS ORDAINED IN APPROPRIATION ORDINANCE NO. 2020-38**

**EXPLANATORY NOTE**

The Local Government Unit (LGU) of the City of Naga, as a growing City in Metropolitan Cebu, is faced with a myriad of challenges following its conversion into a new component city in 2007.

To keep abreast with its socio-economic development and rapid urbanization, the city leadership had to alter the original projects plan, introduce additional or new projects thereof as ordained in Appropriation Ordinance (AO) No. 2020-38.

The 4<sup>th</sup> City Council enacted AO No. 2020-38 in its 58<sup>th</sup> regular session on August 12, 2020 approving Supplemental Budget No. 07 for Calendar Year (CY) 2020 containing the amount of Five Hundred Million Pesos (P500,000,000.00).

Originally, the funding allocation was intended to finance three (3) major infrastructure projects, namely, City of Naga Integrated Management Information System (ICT equipment), coastal development project in Barangay North Poblacion (seaport system), and construction of two (2) bridges (road networks).

In its March 25, 2025 letter endorsement, the Office of the City Budget Officer formally requested this Sanggunian for the amendment of the aforementioned original projects, including new or additional ones being funded thru the Development Bank of the Philippines loans, such as the coastal development project in Barangay North Poblacion, construction of two concrete bridges and a bypass road.

**NOW THEREFORE, BE IT ORDAINED**, as it is hereby **ORDAINED** by the 5<sup>th</sup> Sangguniang Panlungsod (SP) of the City of Naga, Cebu, in a session duly assembled, by virtue of the powers vested in it by law, that:

**SECTION 1. TITLE.** - This Ordinance shall be known as **"CONFIRMING THE REVISIONS, CHANGES AND/OR AMENDMENTS OF THE ORIGINAL PROJECTS, PURPOSES AND CORRESPONDING COSTS AS ORDAINED IN APPROPRIATION ORDINANCE NO. 2020-38.**



**SECTION 2. PURPOSE.** - The primary purpose of changing or revising the original projects plan is to ensure that its implementation truly aligns with the LGU's development goals, maximize the use of its available resource, and ultimately address the needs and priorities of the city's constituents.

**SECTION 3. SCOPE/COVERAGE.** - This Ordinance covers the original projects plan, the revisions/changes and corresponding costs thereof, with details specified below as follows, viz:

Additional/New Project: Construction of a bypass road - <b>₱100,000,000.00</b>	New Project: Construction of a bypass road - <b>₱100,000,000.00</b>

**SECTION 4. RATIFICATION.** - With the goal of better addressing local needs and priorities, this Sanggunian, upon the recommendation of the concerned SP Committees, hereby ratifies the above-enumerated revisions/changes, and/or amendments of the projects plan including the amended costs, terms and conditions, timelines and implementation thereof.


**SECTION 5. SEPARABILITY CLAUSE.** - Any part or provision of this Ordinance which is prohibited or held void shall not affect the independent remaining portions hereof.

**SECTION 6. EFFECTIVITY CLAUSE.** - This Ordinance shall take effect upon approval and compliance with the requirements set forth by law. It shall also be retroactive to the period wherein this LGU has commenced the implementation and revision of the projects plan as a form of ratification as should be fairly so.
