## **RESOLUTION NO. 1788-2024**

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO ENTER INTO A CONTRACT RENEWAL AGREEMENT WITH ATTY. VICTOR ALINSUG MAAMBONG AS LEGAL CONSULTANT OF THE 5<sup>TH</sup> SANGGUNIANG PANLUNGSOD (SP) FOR A TERM OF SIX (6) MONTHS FROM JANUARY 01, 2025 TO JUNE 30, 2025 IN THE AMOUNT OF FORTY THOUSAND PESOS (₱40,000.00) PER MONTH

WHEREAS, Republic Act (R.A.) 7160, otherwise known as the Local Government Code of 1991, vested exclusive authority upon legal officers to be counsel of local government units (LGU);

WHEREAS, subjected to deliberation is the proposal to renew the services of Atty. Victor Alinsug Maambong as legal consultant of the 5th SP for a term of six months from January 01, 2025 to June 30, 2025 at ₱40,000.00 per month;

WHEREAS, the consultancy work of Atty. Maambong has been considered "highly technical" pursuant to Section 53.7 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, otherwise known as the Government Procurement Reform Act;

WHEREAS, this Sanggunian deems Atty. Maambong's consultancy services necessary to ensure efficiency in the drafting, revision and review of proposed resolutions and ordinances, and continuity of this LGU's developmental programs and projects through the enactment of updated or new legislative measures.

NOW THEREFORE, on motion of Hon. Carmelino N. Cruz, Jr., seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize as it hereby authorizes the Honorable City Mayor Valdemar M. Chiong to enter into a Contract Renewal Agreement with Atty. Victor Alinsug Maambong as legal consultant of the 5th SP for a term of six (6) months from January 01, 2025 to June 30, 2025 in the amount of Forty Thousand Pesos (₱40,000.00) per month.
