**WHEREAS**, the Sangguniang Panlungsod enacted Ordinance No. 2017-014, entitled: "Establishing the CN-CSTCA, to cater to the education needs of selected secondary students in the areas of science, technology, theater arts, dance, music, creative writing and visual arts";

**WHEREAS**, the City of Naga Local School Board passed Resolution No. 067-2024, series of 2024 dated December 27, 2024, approving the request for the renewal of service contracts of ballet dancing and music/voice trainers for the period January 02, 2025 until December 31, 2025 for CN-CSTCA chargeable against the Special Education Fund (SEF) 2025 – Honoraria;






