**WHEREAS**, the Senior High School (SHS) curriculum of the Department of Education (DepEd) mandates work immersion for all SHS students as part of the K to 12 basic education reform program with the primary objective of preparing the graduates of their employment, entrepreneurship and higher learning;

**WHEREAS**, DepEd recognizes the importance of having a school-industry partnership in order for the SHS learners to acquire necessary expertise, venue for practical, on-the-job, enterprise-based training;

**WHEREAS**, St. Cecilia's College-Cebu, Inc., a private high school with principal address at N. Bacalso South National Highway, Minglanilla, Cebu, is among those that entered into a work immersion partnership agreement with the City Government of Naga, Cebu;
