**RESOLUTION NO. 1827-2025**

**APPROVING THE EXTENSION OF THE APPLICATION FOR BUSINESS PERMIT RENEWAL FROM JANUARY 20, 2025 TO JANUARY 31, 2025 TO ACCOMMODATE THE INFLUX OF BUSINESS PERMIT APPLICANTS OF THE CITY OF NAGA, CEBU**

**WHEREAS**, the Business Permit and Licensing Office (BPLO) is holding the Business One-Stop Shop, a regular program that processes the issuance of new application and renewal of business permits through fast and simplified means every January of the year at City Hall;

**WHEREAS**, Section 167 (Time of Payment) of RA 7160, otherwise known as the Local Government Code of 1991, mandates that all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter as the case may be;

**WHEREAS**, the same section of RA 7160 further states that *"the local sanggunian may, for a justifiable reason or cause, extend the time for payment of such taxes, fees and charges without surcharges or penalties for a period not exceeding six (6) months;"*

**WHEREAS**, Acting City Treasurer Trina L. Litorja requested this Sanggunian to extend the time for business permit renewal from January 20, 2025 to January 31, 2025 to fully accommodate the increasing number of business permit clients and facilitate their submitted documents;

**WHEREAS**, the purpose of the time extension is to enable the City Government to reach its target collection on local business taxes, fees and charges for Calendar Year 2025.

**NOW THEREFORE**, on motion of Hon. Letecia F. Abangan, seconded by Hon. Charmaine R. Navarro, for the approval of the resolution, be it

**RESOLVED**, as it is hereby **RESOLVED**, to approve the extension of the application for business permit renewal from January 20, 2025 to January 31, 2025 to accommodate the influx of business permit applicants of the City of Naga, Cebu.
