RESOLUTION NO. 1828-2025

APPROVING AND ADOPTING THE AMENDMENT OF THE TOURISM, CULTURE AND HERITAGE DEVELOPMENT PLAN FOR CALENDAR YEAR (CY) 2025 TO DEFRAY THE COST FOR THE CITY GOVERNMENT OF NAGA, CEBU'S PARTICIPATION IN SINULOG SA **SUGBO 2025**

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates all local government units (LGUs) to develop and promote tourism and the general welfare in their respective area of jurisdictions;

WHEREAS, the City Information and Community Relations Office (CICRO) forwarded to this Sanggunian the proposed amendment of this LGU's Tourism, Culture and Heritage Development Plan (TCHDP) for CY 2025 to defray the expenses to be incurred during the city's participation in Sinulog sa Sugbo 2025, an annual cultural and religious festival in honor of the Señor Santo Niño;
