GRANTING SEVEN THOUSAND PESOS (\$7,000.00) MONTHLY HONORARIUM TO ATTY. RICHELL MARIE D. SENAGAN IN HER CAPACITY AS PROSECUTION ATTORNEY WITH PERMANENT STATUS ASSIGNED TO THE CITY OF NAGA PROSECUTOR'S OFFICE **EFFECTIVE DECEMBER 10, 2024**

WHEREAS, Section 458 (1) (xi) of RA 7160 or the Local Government Code of 1991 states that when the finances of the city allow, the City Government "shall provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed in or assigned to the city;"

WHEREAS, in the exigency of public service and to properly serve the people of the City of Naga, Cebu, the Honorable Secretary of Justice, Jesus Crispin C. Remulla has assigned Atty. Senagan at the City Prosecutor's Office with permanent status to assist in its day-to-day operations especially in resolving preliminary investigation cases;

WHEREAS, the Honorable City Mayor Valdemar M. Chiong favorably endorsed to this Body that a resolution be passed granting ₱7,000.00 monthly honorarium to the newly assumed Prosecutor Attorney effective December 10, 2024;

WHEREAS, this Sanggunian, in a session duly assembled, deemed it appropriate to grant the abovementioned monthly honorarium to the new Prosecution Attorney whose office plays a vital role in effective and efficient prosecution service in the City of Naga, Cebu.

NOW THEREFORE, on motion of Hon. Carmelino N. Cruz, Jr., seconded by Hon. Aurelio B. Alinsonorin, for the approval of the resolution, be it
