RESOLUTION NO. 1832-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO ENTER INTO NEGOTIATIONS, SIGN AND EXECUTE CONTRACTS AND/OR AGREEMENTS, OR ANY OTHER NECESSARY DOCUMENTS WITH ZIGS ECO SANITATION CORPORATION FOR THE PROVISION OF SERVICES FOR THE HEALTHCARE WASTE COLLECTION, TRANSPORTATION, TREATMENT AND DISPOSAL FOR VICENTE MENDIOLA CENTER FOR HEALTH (VMCH) IN THE AMOUNT OF ONE HUNDRED SEVENTY-TWO THOUSAND EIGHT HUNDRED PESOS (₱172,800.00)

WHEREAS, the City Government of Naga, Cebu has established its own one-stop healthcare facility - the Vicente Mendiola Center for Health (VMCH) with the primary objective of providing immediate, quality, accessible yet affordable healthcare services to the city residents;

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) official website a "Request for Quotation to PhilGEPS-registered suppliers for the project: Provision of services for the healthcare waste collection, transportation, treatment and disposal for VMCH;"

WHEREAS, the City Government intends to avail of the services of Zigs Eco Sanitation Corporation, a duly licensed Waste Management Services Company registered with the Securities and Exchange Commission and Department of Environment and Natural Resources – Environmental Management Bureau;

WHEREAS, as stated in the Service Agreement, the City Government shall pay the services rendered by Zigs Eco Sanitation Corporation based on the statement of account/invoices issued by the latter up to the total amount of ₱144,000.00 or until the said amount is fully utilized.

NOW THEREFORE, on motion of Hon. Carmelino N. Cruz, Jr., seconded by Hon. Aurelio B. Alinsonorin, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to enter into negotiations, sign and execute contracts and/or agreements, or any other necessary documents with Zigs Eco Sanitation Corporation for the provision of services for the healthcare waste collection, transportation, treatment and disposal for VMCH in the amount of One Hundred Seventy-Two Thousand Eight Hundred Pesos (₱172,800.00).
