**APPROVING THE CHARGING OF THE PURCHASE OF THREE (3) LOTS LOCATED IN BARANGAYS COLON AND INAYAGAN, CITY OF NAGA, CEBU, RESPECTIVELY, AGAINST LUMP SUM APPROPRIATION SPECIFICALLY MAYOR'S OFFICE-CAPITAL OUTLAY-LAND IN THE TOTAL AMOUNT OF SEVENTEEN MILLION EIGHT HUNDRED NINETY-FIVE THOUSAND AND FIVE HUNDRED PESOS (P17,895,500.00)**






