RESOLUTION NO. 1836-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF THE CITY GOVERNMENT OF NAGA, CEBU, A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE (FO) VII FOR THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS (SPISC) IN THE TOTAL AMOUNT OF TWENTY-SEVEN MILLION SEVENTY-TWO THOUSAND PESOS (P27,072,000.00)

WHEREAS, Section 17(b)(2)(iv) of Republic Act (RA) No. 7160 or the Local Government Code of 1991 mandates the municipality/city to provide "Social welfare services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, **welfare of the elderly and disabled persons** community-based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents, and victims of drug abuse; livelihood and other pro-poor projects; nutrition services; and family planning services;"

WHEREAS, RA No. 12116 or the General Appropriation Act (GAA) for Fiscal Year 2025 states that "the amount of P49,807,050,000.00 appropriated herein shall be used for the monthly stipend amounting to One Thousand Pesos (P1,000.00) of the identified senior citizen beneficiaries, as determined by the DSWD;"

WHEREAS, the Office of the City Legal Officer has requested this Sanggunian for the passage of a resolution authorizing the Local Chief Executive to enter into a MOA with DSWD FO VI, the lead agency, for the implementation of the SPISC in the City of Naga, Cebu with the total amount of P27,072,000.00 for 2,256 identified beneficiaries in the city's 28 barangays.



RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a MOA with the DSWD FO VI for the implementation of the SPISC in the total amount of Twenty-Seven Million Seventy-Two Thousand Pesos P27,072,000.00.


