RESOLUTION NO. 1837-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A CONTRACT OF AGREEMENT WITH ARQ BUILDERS FOR THE PROJECT: SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR THE PROPOSED BAYWALK (CONTIGUOUS CONTRACT) AT RECLAMATION PHASE 2, BARANGAY EAST POBLACION, CITY OF NAGA, CEBU IN THE AMOUNT OF FIVE HUNDRED SEVENTY-NINE THOUSAND FIVE HUNDRED SIXTY PESOS (P579,560.00)

WHEREAS, on May 22, 2024, the Sangguniang Panlungsod of the City of Naga authorized the Honorable City Mayor through Resolution No. 1276-2024, to sign, for and in behalf of the City Government, a Contract of Agreement with ARQ Builders for the proposed baywalk at Reclamation Phase 2, Barangay East Poblacion, City of Naga, Cebu;

WHEREAS, the City Government of Naga, Cebu is undertaking the construction of the same baywalk at Reclamation Phase 2, Barangay East Poblacion, City of Naga, Cebu, which is adjoining the contiguous work;

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), resolved to enter into Negotiated Procurement under Section 53.4 (Adjacent or Contiguous) as an Alternative Method of Procurement for the above-stated project;

WHEREAS, the City Government has accepted the offer of ARQ Builders for the execution and completion of such works and remedying of any defects therein in the amount of P579,560.00;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and ARQ Builders, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Contract of Agreement with ARQ Builders for the project: Supply of labor, materials and equipment for the proposed baywalk (Contiguous Contract) at Reclamation Phase 2, Barangay East Poblacion, City of Naga, Cebu in the amount of Five Hundred Seventy-Nine Thousand Five Hundred Sixty Pesos (P579,560.00).
