## **RESOLUTION NO. 1839-2025**

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, THE REVISED TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF EDUCATION (DEPED) NAGA CITY DIVISION OFFICE AND THECHALKBOARD, INC. FOR THE IMPLEMENTATION OF THE CITY OF NAGA TUTORING PROGRAM AND APPROVING THE CHANGE OF FUNDING SOURCE FROM GENERAL FUND 2024 TO GENERAL FUND 2025

WHEREAS, the City Government of Naga, Cebu has observed that the quality of education of students has been compromised due to the pandemic, thus, it cited the need to implement an effective and efficient intervention program through the City of Naga, Cebu Tutoring Program, a high-dosage tutoring intervention specifically designed for K-12 learners in public schools which focuses on literacy;

WHEREAS, the City Government and DepEd City of Naga Division Office felt the urgency to enter into a partnership through the City of Naga Tutoring Program with THECHALKBOARD, Inc. as the service provider, which will cater 450 non-readers from Grades 1-6 with 225 learners for the first batch, coming from the city's public elementary schools;

WHEREAS, on November 13, 2024, the City Council passed Resolution No. 1681-2024. authorizing the local chief executive to sign a Tripartite MOA with DepEd and TheChalkboard, Inc. for this tutoring program. However, the MOA was not implemented due to threshing of issues;

WHEREAS, as stated in the revised MOA, the City Government will fund the implementation of the tutoring initiative to commence upon receipt of Notice to Proceed, provided that the funding source be changed from General Fund 2024 to General Fund 2025;

NOW THEREFORE, on motion of Hon. Clint Isidro A. Chiong, seconded by Hon. Scott Juvenal A. Chiong for the approval of the resolution, be it

**RESOLVED**, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, the revised Tripartite MOA with the DepEd City of Naga Division Office and THECHALKBOARD, Inc. for the implementation of the City of Naga Tutoring Program and approving the change of funding source from General Fund 2024 to General Fund 2025.
