RESOLUTION NO. 1840-2025

APPROVING THE DRUG-FREE WORKPLACE PROGRAM (FOR CY 2025 – FIRST SEMESTER) CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF TWO HUNDRED EIGHTY-EIGHT THOUSAND PESOS (₱288,000.00)

WHEREAS, the drug issue is undoubtedly a public health challenge that must be prioritized because it creates complex health and social problems;

WHEREAS, the Drug-Free Workplace Program intends to educate employees on the problems relating to substance abuse and to stop any illegal drug-related activities in order to achieve a safe and drug-free workplace;

WHEREAS, Ms. Darean M. Heyrosa, Human Resource Management Officer III, formally requested this Sanggunian for the passage of a resolution approving the drug-free workplace program (for CY 2025 – First Semester), with details specified below:
