APPROVING THE NAGA ATONG GARBO (NAGa) PROGRAM – 1ST QUARTER 2025 (JANUARY 2025 – MARCH 2025) CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF TWO HUNDRED TWENTY-TWO THOUSAND SEVEN HUNDRED PESOS (P222,700.00)

WHEREAS, the Naga Akong Garbo or NAGa which evolved into Naga Atong Garbo (NAGa), is a multi-component program of the City Government of Naga which encompasses all existing and future projects and interventions of the City Government, both mandatory and discretionary;

WHEREAS, the program is integrated and holistic, designed to respond to a wide range of problems, issues and concerns in the city, utilizing the capabilities and capacities of the City Government and the stakeholders;




