RESOLUTION NO. 1846-2025

GRANTING FINANCIAL ASSISTANCE TO BARANGAY TUYAN IN THE TOTAL AMOUNT OF TWO MILLION TWO HUNDRED PESOS (₱2,200,000.00) FROM THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG UNDER THE ACCOUNT: AID TO VARIOUS BARANGAYS 2025 TO FUND THE INSTALLATION OF CLOSED-CIRCUIT TELEVISION (CCTV) AND SOLAR LIGHTS AND APPROVING THE TRANSFER OF THE AFOREMENTIONED AMOUNT TO THE BARANGAY ACCOUNT

WHEREAS, the Sangguniang Barangay of Tuyan passed Resolution No. 150, series of 2024 requesting financial assistance from the Honorable City Mayor Valdemar M. Chiong totaling ₱2,200,000.00 to fund the barangay's priority projects for Calendar Year (CY) 2025 specified below as follows:

- Installation of CCTV amounting to One Million Five Hundred Thousand Pesos (₱1,500,000.00); and
- Installation of solar lights amounting to Seven Hundred Thousand Pesos (₱700,000.00).

WHEREAS, the Sangguniang Barangay of Tuyan, in its regular session on December 02, 2024, deemed the necessity of the abovementioned projects to ensure the security, safety, comfort and convenience of the barangay residents;

WHEREAS, the Barangay further requested that the aforementioned financial assistance be transferred to the barangay account for the implementation of the above-stated projects;

WHEREAS, this Sanggunian deemed it appropriate to approve the request, as these barangay projects are in line with the development and infrastructure programs of the present administration.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to grant financial assistance to Barangay Tuyan in the total amount of Two Million Two Hundred Pesos (₱2,200,000.00) from the Honorable City Mayor Valdemar M. Chiong under the account: Aid to Various Barangays 2025 to fund the installation of CCTV and solar lights in the barangay and approving the transfer of the aforementioned amount to the barangay account.
