RESOLUTION NO. 1852-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A CONTRACT OF AGREEMENT WITH E.C. MANUBAG BUILDERS FOR THE IMPROVEMENT OF ONE (1)-UNIT CLASSROOM TO BE USED AS A ROBOTIC HUB IN BARANGAY INOBURAN, CITY OF NAGA, CEBU AMOUNTING TO THREE HUNDRED FOURTEEN THOUSAND SEVEN HUNDRED SIXTY-TWO PESOS AND 44/100 (₱314,762.44)

WHEREAS, the City Government of Naga, Cebu, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) official website the Request for Quotation for the project: "Supply of labor, materials and tools for the improvement of one (1)-unit classroom to be used as a robotic hub in Barangay Inoburan, City of Naga, Cebu;"

WHEREAS, in the Abstract of Quotation dated November 25, 2024, E.C Manubag Builders, represented by its authorized representative Engr. Evelio C. Manubag, has submitted its bid price in the amount of ₱314,762.44 and was found to be the lowest calculated and responsive price quotation for the project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and E.C Manubag Builders, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Contract of Agreement with E.C. Manubag Builders for the improvement of one (1)-unit classroom to be used as a robotic hub in Barangay Inoburan, City of Naga, Cebu amounting to Three Hundred Fourteen Thousand Seven Hundred Sixty-Two Pesos and 44/100 (₱314,762.44).
