APPROVING THE SUPPLY OF MATERIALS AND LABOR FOR THE FABRICATION AND INSTALLATION OF SOLAR LIGHTS AT RECLAMATION PHASE 1 AND 2, BARANGAY EAST POBLACION, CITY OF NAGA, CEBU CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF SIX HUNDRED SIXTY-EIGHT THOUSAND ONE HUNDRED PESOS (₱668,100.00)

WHEREAS, the Office of the City Planning and Development Coordinator forwarded a request to this Sanggunian for approval of the procurement of supply of materials and labor for the fabrication and installation of solar lights at Reclamation Phase 1 and 2, Barangay East Poblacion, City of Naga, Cebu, with details specified hereunder, viz:
