APPROVING THE PURCHASE OF MATERIALS FOR THE IMPROVEMENT OF VARIOUS COVERED COURTS IN THE CITY OF NAGA, CEBU (LOCATED IN BARANGAYS INAYAGAN, TUYAN, COLON, TANGKE, LANGTAD, NAALAD, PANGDAN, CANTAO-AN, SOUTH POBLACION, AT NAGA CENTRAL ELEMENTARY SCHOOL [ES], NAGA NATIONAL HIGH SCHOOL, LANGTAD ES AND ENAN CHIONG ACTIVITY CENTER [ECAC]) CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (P800,000.00)

WHEREAS, subjected to deliberation is the request of City Engineer Ma. Alpha P. Alojado for the passage of a resolution approving the purchase of materials for the improvement of various covered courts in the City of Naga, Cebu, with details specified hereunder, viz:

 - 1) Inayagan; 2) Tuyan; 3) Colon; 4) Tangke; 5) Langtad; 6) Naalad; 7) Pangdan;
 - 8) Cantao-an; 9) South Poblacion; 10) Naga Central ES; 11) Naga National High School; 12) Langtad ES; and 13) ECAC;

WHEREAS, this Sanggunian deemed it justifiable to approve the funding allocation for these projects after it ascertained the availability of funds pursuant to the developmental plans and programs of this administration.
