RESOLUTION NO. 1857-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A MEMORANDUM OF AGREEMENT (MOA) WITH THE CITY'S TWENTY-EIGHT (28) PUNONG BARANGAYS FOR AUTOMATIC DEDUCTION FROM REAL PROPERTY TAX (RPT) SHARE THE AMOUNT OF ELECTRICITY BILL FOR STREET LIGHTS

WHEREAS, Section 16 of R.A. 7160 otherwise known as the Local Government Code of 1991 mandates every local government unit (LGU) to promote the general welfare, health and safety, peace and order, and preserve the comfort and convenience of its inhabitants;

WHEREAS, subjected to deliberation is the proposed MOA between the City Government of Naga, Cebu and the 28 Punong Barangays for automatic deduction from their respective barangay RPT share the electricity bill for street lights;

WHEREAS, the City Government finds the automatic deduction from the barangay RPT share the monthly electricity consumption of street lights as the convenient method to continue the operation and maintenance of street lights;

WHEREAS, the August Body considers this payment scheme practical and necessary to ensure that power supply of street lights located in the city's barangays is not interrupted due to delayed or non-payment of electricity bill.

NOW THEREFORE, on motion of Hon. Letecia F. Abangan, seconded by Hon. Carmelino N. Cruz, Jr. for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu a MOA with the city's 28 barangays for automatic deduction from RPT share the amount of electricity bill for street lights.
