RESOLUTION NO. 1858-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, THE CONTRACTS OF SERVICE OF NINE (9) NEW TEACHER AIDES WITH A MONTHLY HONORARIUM OF TEN THOUSAND FIVE HUNDRED PESOS (₱10,500.00) EACH EFFECTIVE FEBRUARY 03, 2025 UNTIL DECEMBER 31, 2025 PURSUANT TO THE JOINT PROJECT OF THE CITY GOVERNMENT AND DEPARTMENT OF EDUCATION (DEPED) KNOWN AS PROJECT SAVING GRADES AND DROP-OUTS (SAGRADO)

WHEREAS, the Project SAGRADO was approved through City of Naga School Board Resolution No. 018-2016, wherein the hiring of locally-funded teacher aides is instituted in response to the high rise incidence of failures and dropping-out of students;

WHEREAS, the City Government and the DepEd City of Naga Schools Division mutually recognized the need to engage the services of teacher aides especially with the thrust to reduce drop-out and failure rates and improve the quality of education in the city pursuant to the Project SAGRADO.

WHEREAS, the project has greatly contributed in lessening the rate of failures and dropout of students in the City as reported to the City of Naga School Board;

WHEREAS, this Body, in a session duly assembled, deemed it justifiable to tap the professional services of nine (9) new teacher aides in order to save the students at risk of failing and dropping out.

NOW THEREFORE, on motion of Hon. Clint Isidro A. Chiong, seconded by Hon. Carmelino N. Cruz, Jr., for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, the Contracts of Service of nine (9) new teacher aides with a monthly honorarium of Ten Thousand Five Hundred Pesos (₱10,500.00) each effective February 03, 2025 until December 31, 2025 pursuant to the joint project of the City Government and DepEd known as Project SAGRADO.
