RESOLUTION NO. 1863-2025

FURTHER AMENDING THE COMPOSITION OF THE DIFFERENT STANDING COMMITTEES, DEFINING THE FUNCTIONS, DUTIES AND RESPONSIBILITIES THEREOF OF THE 5TH SANGGUNIANG PANLUNGSOD OF THE CITY OF NAGA, CEBU

WHEREAS, in its inaugural session on June 30, 2022, the 5th Sangguniang Panlungsod (SP) passed Resolution No. 002-2022 approving the creation of the different standing committees consisting of one chairperson, one vice chairperson and three regular members, respectively;

WHEREAS, on December 28, 2023, the City Council passed Resolution No. 994-2023 approving the amendment of the composition of the aforementioned standing committees following the election of former SP Member, Hon. Luzminda R. Lapitan as the new barangay captain of Tuyan, City of Naga, Cebu and the assumption of new Sangguniang Kabataan (SK) Federation President, Hon. Faith James B. Servano;

WHEREAS, in its January 31, 2025 regular session, the August Body reached a consensus to amend further the composition of the existing committees on account of the assumption of new SP Member, Hon. Amelita M. Lara, who replaced her late husband, the late City Councilor Alexander R. Lara, and is serving the unexpired portion of the latter's term;

WHEREAS, in the interest of effective legislation and to achieve highest degree of efficiency, this Sanggunian designated Hon. Justino L. Dakay as the new chairperson of the Committee on Heritage, Culture and the Arts, while Hon. Amelita M. Lara will chair the Committee on Public Transportation, Franchising and Regulation;


