RESOLUTION NO. 1864-2025

APPROVING THE MONTHLY REPRESENTATION AND TRANSPORTATION ALLOWANCE (RATA) OF FIFTEEN THOUSAND THREE HUNDRED PESOS (\$\frac{1}{2}\$15,300.00) AND MOBILE PHONE LOAD ALLOWANCE OF TWO THOUSAND PESOS (\$\frac{1}{2}\$2,000.00) OF HON. AMELITA M. LARA IN HER CAPACITY AS A MEMBER OF THE 5TH SANGGUNIANG PANLUNGSOD (SP) EFFECTIVE JANUARY 13, 2025

WHEREAS, Hon. Amelita M. Lara, a resident of Barangay Tuyan, City of Naga, Cebu, officially took her oath as a new member of the 5th SP before the Honorable Cebu Governor Gwendolyn F. Garcia on January 13, 2025;

WHEREAS, she joined the City Council regular session on January 15, 2025, formally assuming the vacant seat left behind by her late husband, City Councilor Alexander R. Lara, who passed away on November 23, 2024 due to complications of a serious illness;

WHEREAS, records show that Hon. Lara has complied with all the pertinent requirements, including the endorsement of this Sanggunian, that made her eligible to assume the aforementioned post;

WHEREAS, Hon. Lara is entitled to receive the monthly RATA of ₱15,300.00 and mobile phone load allowance of ₱2,000, respectively, in her capacity as a new lady legislator of the local sanggunian.

NOW THEREFORE, on motion of Hon. Carmelino N. Cruz, Jr., duly seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to approve the monthly RATA of Fifteen Thousand Three Hundred Pesos (₱15,300.00) and mobile load allowance of Two Thousand Pesos (₱2,000.00) of Hon. Amelita M. Lara in her capacity as a member of the 5th SP effective January 13, 2025.
