RESOLUTION NO. 1866-2025

APPROVING THE SUPPLY AND DELIVERY OF A UTILITY VAN TO BE DEPLOYED IN BARANGAY CENTRAL POBLACION, CITY OF NAGA, CEBU CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (\$\frac{1}{2}800,000.00)

WHEREAS, submitted for consideration is the request of Ms. Gineveve V. Laput for the passage of a resolution approving the supply and delivery of a utility van to be deployed in Barangay Central Poblacion, City of Naga, Cebu with details specified hereunder, viz:

- LUMP SUM APPROPRIATION GEN. FUND 2025 SUBSIDY TO LGUs/ AID TO BARANGAY (OFFICE OF THE CITY MAYOR)
 - Supply and delivery of vehicle (utility van),
 Barangay Central Poblacion, City of Naga, Cebu

- ₱800,000.00

Fund 2025 – Subsidy to LGUs/Aid to Barangay (Office of the City Mayor) in the amount of Eight Hundred Thousand Pesos (₱800,000.00).
