FAVORABLY ENDORSING THE APPLICATION FOR RENEWAL OF SMALL SCALE QUARRY PERMIT (SSQP) OF TOLEDO AGGREGATES CONSTRUCTION AND DEVELOPMENT CORPORATION LOCATED IN BARANGAY COGON, CITY OF NAGA, CEBU

WHEREAS, subjected to deliberation is the application for renewal of the SSQP of Toledo Aggregates Construction Development Corporation (TACDC), represented by its General Manager, Ms. Agnes C. Chan, located in Barangay Cogon, City of Naga, Cebu with an area of Thirty-Nine Thousand Eight Hundred Fifty-Two (39,852) square meters or 3.98 hectares;

WHEREAS, the Office of the City Environment and Natural Resources favorably endorsed to the Office of the City Mayor the application for renewal of TACDC's quarry permit after finding that all the submitted documents such as Quarry Permits issued by Cebu Provincial Government, Quarry Permit Development Plan, Lot Zoning Certificate, among others, to be in order;

WHEREAS, on November 08, 2024, the Sangguniang Barangay of Cogon, City of Naga, Cebu passed Resolution No. 57 series of 2024 expressing approval for the renewal of TACDC's quarry permit with attached photos, attendance and minutes of the barangay public hearing;

WHEREAS, after a careful evaluation, this Sanggunian likewise found that the application for renewal of TACDC's SSQP to be in order and deemed it proper to endorse the same to Cebu Provincial Environment and Natural Resources Office (PENRO) for approval.
