APPROVING THE PROPOSED PROGRAM, TITLED: "QUALIFYING EXAMINATION FOR THE CITY OF NAGA CEBU COLLEGE SCHOLARSHIP PROGRAM (BATCH 12) SCHOOL YEAR (SY): 2025-2026" CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF EIGHTY-NINE THOUSAND FIVE HUNDRED PESOS (₱89,500.00)

WHEREAS, the City Government of Naga recognizes the importance of college education for deserving Grade 12 school graduates of the City, particularly those who do not have the resources to pursue college education:

WHEREAS, one of the requirements to avail of the scholarship program is to pass the qualifying competitive examination to be facilitated by the city's Technical Working Group (TWG);

WHEREAS; the Office of the City Information and Community Relations Officer requested this Body for the passage of a resolution approving the use of funds for the qualifying examination for the City of Naga Cebu College Scholarship Program (Batch 12) for SY: 2025-2026;

WHEREAS, this August Body, in a session duly assembled, found it necessary to approve the request for funding allocation for the success of the said examination so as to support and improve the quality education of the new graduates.

Fund 2025 - Other Maintenance and Operating Expenses (Office of the City Mayor) in the amount of Eighty-Nine Thousand Five Hundred Pesos (₱89,500.00).
