**RESOLUTION NO. 1885-2025**

**AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A MEMORANDUM OF AGREEMENT (MOA) WITH RENAL CENTERS OF AMERICA FORMALIZING THE LEASE OF A PORTION ON THE GROUND FLOOR OF A MULTI-PURPOSE BUILDING FOR THE ESTABLISHMENT OF THE LATTER'S DIALYSIS CENTER IN BARANGAY EAST POBLACION, CITY OF NAGA, CEBU**

**WHEREAS**, Section 8 of Republic Act 9491, otherwise known as the Charter of the City of Naga, Cebu provides that the City Mayor shall initiate and maximize the generation of resources and revenues, and apply the same to the implementation of the development plans, program objectives and priorities;

**WHEREAS**, Renal Centers of America (RCA) has expressed its interest, through a letter of intent dated February 14, 2025, to lease a city-owned space, specifically 313.55 square meters for the establishment and operation of a state-of-the-art dialysis center;

**WHEREAS**, the letter, signed by Mr. Ryan Alicaya, stated that the RCA's goal is to provide free dialysis treatments to ensure accessibility for all patients with the proper maintenance of the highest standards of hygiene and safety;

**WHEREAS**, the City Legal Office has formally endorsed to this Sanggunian for its appropriate action the intent of RCA, attaching therein the proposed MOA authorizing the dialysis provider to lease a portion on the ground floor of a multi-purpose building located near the Enan Chiong Activity Center in Barangay East Poblacion.

**NOW THEREFORE**, on motion of Hon. Aurelio B. Alinsonorin, seconded by Hon. Elmer John R. Lapitan, for the approval of the resolution, be it

**RESOLVED**, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, a MOA with Renal Centers of America formalizing the lease of a portion on the ground floor of a multi-purpose building for the establishment of the latter's dialysis center in Barangay East Poblacion, City of Naga, Cebu.
