NAGA, AS AMBASSADRESS OF THE CITY OF NAGA, CEBU, WITH TEN THOUSAND PESOS (P10,000.00) MONTHLY HONORARIUM UNTIL THE CROWNING OF THE NEXT BB. NAGA**

**WHEREAS**, the City Government expresses its desire to engage the services of Ms. Virly L. Mellado, the reigning BB. Naga 2024, to promote the city's tourism, culture and community engagement;

**WHEREAS**, Ms. Mellado, a resident of Barangay South Poblacion, City of Naga, Cebu, has accepted the responsibilities and duties associated with the title and agreed to represent the City of Naga-Local Government Unit (LGU) in accordance with the terms and conditions set forth in the proposed Contract of Service;

**WHEREAS**, Ms. Mellado plays a significant role as an ambassadress to showcase the city's cultural heritage, tourism potentials, and public image to both local and international audiences;

**WHEREAS**, the City of Naga-LGU shall pay Ms. Mellado the amount of Ten Thousand Pesos (P10,000.00) in consideration of her services rendered in relation to her role as the city's ambassadress.
