**RESOLUTION NO. 1888-2025**

**AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH BRIGHT STAR INDUSTRIES, INC., FOR THE PROCUREMENT OF MEALS FOR VICENTE MENDIOLA CENTER FOR HEALTH (VMCH) – INFIRMARY, CITY OF NAGA, CEBU FOR THE PERIOD: JANUARY TO DECEMBER 2025 IN THE AMOUNT OF FOUR MILLION SEVEN HUNDRED EIGHTY-NINE THOUSAND THREE HUNDRED TWENTY-TWO PESOS AND 37/100 (P4,789,322.37)**

**WHEREAS**, the VMCH-Infirmary, City of Naga's one-stop health facility, is mandated to provide three basic meals for its in-house patients and resident physicians in compliance with the requirements of the Department of Health;

**WHEREAS**, the City Government of Naga, through its Bids and Awards Committee (BAC), conducted a public bidding on January 27, 2025 for the "Procurement of meals for VMCH Infirmary for January to December 2025;"

**WHEREAS**, the BAC declared Bright Star Industries, Inc., a corporation with business address at 58-60 Plaridel St., Cebu City, as the winning bidder for submitting the single calculated and responsive bid for the above-stated project in the amount of P4,789,322.37;

**WHEREAS**, this Sanggunian, in a session duly assembled, ascertained the capability of Bright Star Industries, Inc. to deliver and provide regular balanced diet food supply at VMCH-Infirmary with the above-stated corresponding budget.

**NOW THEREFORE**, on motion of Hon. Scott Juvenal A. Chiong, seconded by Hon. Aurelio B. Alinsonorin for the approval of the resolution, be it

**RESOLVED**, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, a Contract of Agreement with Bright Star Industries, Inc., for the procurement of meals for VMCH – Infirmary, City of Naga, Cebu for the period: January to December 2025 in the amount of Four Million Seven Hundred Eighty-Nine Thousand Three Hundred Twenty-Two Pesos and 37/100 (P4,789,322.37).
