RESOLUTION NO. 1890-2025

GRANTING THE REQUEST OF MS. GENELYN ABATAYO TO CONTINUE THE OPERATION OF THE COCKPIT ARENA IN BARANGAY ULING, CITY OF NAGA, CEBU WITHIN SIX (6) MONTHS OR FROM FEBRUARY 06, 2025 TO AUGUST 2025 PENDING **ISSUANCE OF A FRANCHISE PERMIT**

WHEREAS, Ms. Genelyn Abatayo, owner of a cockpit arena in Barangay Uling, City of Naga, Cebu, wrote a letter dated February 03, 2025 to the Office of the City Mayor asking permission to operate the cockpit pending issuance of a franchise permit;

WHEREAS, Ms. Abatayo, who signed a notarized Affidavit of Undertaking, assured to submit all the necessary permits for the operation of the Uling Cockpit within six months or until August 2025 upon execution of the Affidavit of Undertaking;

WHEREAS, Ms. Abatayo revealed that she is still in process of completing pertinent documents for the acquisition of a private lot where the Cockpit Arena currently stands, hence the delay in securing the necessary regulatory permits:

WHEREAS, Section 14 of Ordinance No. 2024-34, otherwise known as an "Ordinance Providing for the Establishment, Operation and Maintenance of Cockpits, Regulation of Cockfighting and Imposition of Fees in the City of Naga, Cebu," provides that existing cockpits currently operating within the city shall comply with its provisions upon effectivity thereof;

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Aurelio B. Alinsonorin, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to grant the request of Ms. Genelyn Abatayo to continue the operation of the cockpit arena in Barangay Uling, City of Naga, Cebu within six months or from February 06, 2025 to August 2025 pending issuance of a franchise permit.
