RESOLUTION NO. 1892-2025

APPROVING THE PROVISION OF MEALS AND SNACKS DURING THE SOCIAL PENSION PAY-OUT FOR THE INDIGENT SENIOR CITIZENS CHARGEABLE AGAINST LUMP SUM APPROPRIATION AMOUNTING TO FORTY-FIVE THOUSAND ONE HUNDRED PESOS (₱45,100.00)

WHEREAS, Republic Act No. 9994 or the expanded Senior Citizens Act of 2010 provides additional benefits and institutionalizes social protection by providing social pension to indigent sick and disabled senior citizens;

WHEREAS, the social pension for indigent Filipino senior citizens is in fulfillment of the obligation of the government to protect the most vulnerable sector through the Local Government Unit (LGU) in which the City of Naga, Cebu has identified 2,256 social pensioners who will receive their monthly stipend;

WHEREAS, the Office of the City Social Welfare and Development requested this Sanggunian for the passage of a resolution approving the use of funds for the provision of meals and snacks during the social pension pay-out for the indigent senior citizens on February 27-28, 2025:

WHEREAS, this August Body, in a session duly assembled, deemed it appropriate to approve the funding so as to support the success of this two-day activity.

NOW THEREFORE, on motion of Hon. Letecia F. Abangan, seconded by Hon. Justino L. Dakay, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to approve the provision of meals and snacks during the social pension pay-out for the indigent senior citizens chargeable against lump sum appropriation specifically General Fund 2025 - Other Maintenance and Operating Expenses (Office of the City Mayor) amounting to Forty-Five Thousand One Hundred Pesos (P45,100.00).
