RESOLUTION NO. 1893-2025

APPROVING THE PROVISION OF MEALS FOR THE GENERAL ASSEMBLY OF THE CEBU PROVINCIAL FEDERATION OF CITIES AND MUNICIPALITIES OF SENIOR CITIZENS ASSOCIATION OF THE PHILIPPINES, INC. CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF SEVENTEEN THOUSAND SIX HUNDRED PESOS (₱17,600.00)

Fund 2025 - Other Maintenance and Operating Expenses (Office of the City Mayor) in the amount of Seventeen Thousand Six Hundred Pesos (₱17,600.00).
