RESOLUTION NO. 1895-2025

APPROVING THE PROCUREMENT OF TOKENS TO WEDDED COUPLES OFFICIATED BY THE LOCAL CHIEF EXECUTIVE (LCE) IN THE CITY OF NAGA, CEBU CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF FIFTY-SEVEN THOUSAND SEVEN HUNDRED TWENTY-NINE PESOS AND 15/100 (₱57,729.15)

WHEREAS, the City Government of Naga, Cebu has been conducting regular weekly wedding rites officiated by the LCE every Tuesdays, or any day as approved by the City Mayor;

WHEREAS, as its gesture of support to important family occasions, this local government unit (LGU) is providing pictures of the actual wedding rites and Narra Trees as tokens to couples tied through civil weddings officiated by the LCE;

WHEREAS, these souvenir photos commemorate the couple's union, promote civic engagement and pride, symbolize official recognition, and at the same time, bring this LGU closer to the community.

WHEREAS, this Body considers the request necessary for funding allocation in the amount of ₱57,729.15 to support the provision of tokens to wedded couples at City Hall.

NOW THEREFORE, on motion of Hon. Justino L. Dakay, seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to approve the procurement of tokens to wedded couples officiated by the LCE in the City of Naga, Cebu chargeable against lump sum appropriation specifically Gen. Fund 2025 - Other Maintenance and Operating Expenses (Office of the City Mayor) in the amount of Fifty-Seven Thousand Seven Hundred Twenty-Nine Pesos and 15/100 (₱57,729.15).
