RESOLUTION NO. 1902-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) WITH PNOC RENEWABLES CORPORATION (PNOC RC) AND NCO GENERAL MERCHANDISE FOR THE COMPLETION OF THE 190kWp SOLAR PV ROOFTOP PROJECT AND RESOLUTION OF DAMAGE DONE TO THE CORRUGATED ROOF OF THE LEGISLATIVE BUILDING IN BARANGAY EAST POBLACION, CITY OF NAGA, CEBU

WHEREAS, the City of Naga-LGU and PNOC RC signed a MOA dated September 19, 2023 for the installation of the 190kWp Solar PV System in five (5) City Government-owned buildings, including the Legislative Building that houses the Sangguniang Panlungsod and Museo Naga in Barangay East Poblacion;

WHEREAS, after conducting a public bidding, the PNOC RC Bids and Awards Committee declared NCO General Merchandise as the single responsive calculated bidder and recommended the award of contract thereat for the project;

WHEREAS, the project implementation, however, suffered a delay mainly due to NCO General Merchandise's failure to apply the net metering application with the distribution utility, and the damage caused by the installation of the PV system that resulted to water leaks on the roof of the Legislative Building on June 07, 2024;

WHEREAS, the parties deemed it necessary to enter into an agreement in order to proceed with the remaining works for the completion of the solar PV rooftop project installation and correction of the damaged roof of the Legislative Building.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, a Tripartite MOA with PNOC RC and NCO General Merchandise for the completion of the 190kWp Solar PV Rooftop Project and resolution of damage done to the corrugated roof of the Legislative Building in Barangay East Poblacion, City of Naga, Cebu.
