RESOLUTION NO. 1903-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, THE RENEWAL OF THE CONTRACT OF SERVICE WITH MS. FE ARACELI O. CABIGON AS SKILLS TRAINER FOR COMMERCIAL COOKING, BAKING AND FOOD PROCESSING UNDER THE ALTERNATIVE LEARNING SYSTEM FOR CALENDAR YEAR (CY) 2025

WHEREAS, on February 13, 2025, the City of Naga School Board passed Resolution No. 019-2025 Series of 2025 approving the renewal of contract of the skills trainer for commercial cooking, baking and food processing under the Alternative Learning System (ALS) in the person of Ms. Fe Araceli O. Cabigon;

WHEREAS, Ms. Cabigon, a resident of Barangay Tangke, City of Naga, Cebu has been conducting skills training classes in accordance with the time and schedule set by the ALS Coordinator/Supervisor at Naga Skills Development Center (Ecology Center) in Barangay West Poblacion of this city;

WHEREAS, the City Government recognizes the need to renew the services of Ms. Cabigon to conduct these skills training classes under the ALS effective within CY 2025 until December 31, 2025 with a monthly honorarium of Seven Thousand Five Hundred Pesos (₱7,5000.00) chargeable against Special Education Fund (SEF) 2025 – Honoraria;

WHEREAS, this August Body considers it proper to renew the contract of service of Ms. Cabigon to ensure the continuity of the skills training and development of the out-of-school youth and adults especial those who have been deprived to pursue regular education.

NOW THEREFORE, on motion of Hon. Clint Isidro A. Chiong, seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, the renewal of the Contract of Service with Ms. Fe Araceli O. Cabigon as a skills trainer for commercial cooking, baking and food processing under the ALS for CY 2025.
