**RESOLUTION NO. 1904-2025**

**AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF EDUCATION (DEPED) CITY OF NAGA SCHOOLS DIVISION FOR THE TRANSFER OF FUND AMOUNTING TO TWO MILLION FIVE HUNDRED FORTY-THREE THOUSAND PESOS (P2,543,000.00) IN SUPPORT OF THE LATTER'S PARTICIPATION IN THE CENTRAL VISAYAS REGIONAL ATHLETIC ASSOCIATION (CVIRAA) MEET 2025**

**WHEREAS**, pursuant to the policy of the state to promote physical education and sports programs, the DepEd City of Naga Schools Division will be joining and participating in the annual CVIRAA Meet to be held in Bayawan City, Negros Oriental on March 10-16, 2025;

**WHEREAS**, the Local School Board passed Resolution No. 005-2025 series of 2025 expressing its support of the DepEd Naga's participation in the 2025 edition of the CVIRAA Meet by allocating Four Million Two Hundred Sixty Thousand Seven Hundred Ten Pesos (P4,260,710.00) chargeable against Special Education Fund (SEF) 2025-Sports Academic and Other DepEd Activities;

**WHEREAS**, the City Government shall procure the parade and playing uniforms of the delegates and the athletes' energy booster amounting to One Million Seven Hundred Seventeen Thousand Seven Hundred Ten Pesos (P1,717,710.00), and shall download the P2,543,000.00 to DepEd Naga or the total allocation of P4,260,710.00;

**WHEREAS**, the city leadership has been very supportive of DepEd City of Naga Schools Division in its sports activities and other related events, as it believes that education plays a vital role in the holistic development of the youth.

**NOW THEREFORE**, on motion of Hon. Clint Isidro A. Chiong, seconded by Hon. Carmelino N. Cruz, Jr., for the approval of the resolution, be it

**RESOLVED**, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a MOA with the DepEd City of Naga Schools Division for the allocation and transfer of fund amounting to Two Million Five Hundred Forty-Three Thousand Pesos (P2,543,000.00) in support of the latter's participation in the CVIRAA Meet 2025.
