RESOLUTION NO. 1906-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A CONTRACT OF AGREEMENT WITH E.C. MANUBAG BUILDERS FOR THE PROPOSED MULTI-PURPOSE BUILDING PHASE 3 (CONTIGUOUS CONTRACT) IN BARANGAY EAST POBLACION, CITY OF NAGA, CEBU IN THE AMOUNT OF FOUR MILLION THREE HUNDRED NINETY-SEVEN THOUSAND SEVEN HUNDRED SIXTY PESOS AND 02/100 (P4,397,760.02)

WHEREAS, on June 26, 2024, the Sangguniang Panlungsod authorized the Honorable City Mayor through Resolution No. 1367-2024 to sign, for and in behalf of the City Government, a Contract of Agreement (the "original contract") with E.C. Manubag Builders for the proposed multi-purpose building phase 2 in Barangay East Poblacion, City of Naga, Cebu;

WHEREAS, the City Government of Naga is undertaking the Phase 3 of the construction of the same multi-purpose building in Barangay East Poblacion which is directly adjacent or contiguous to the original contract;

WHEREAS, the City Government, through the Bids and Awards Committee, resolved to enter into Negotiated Procurement under 53.4 (Adjacent or Contiguous) as an Alternative Method of Procurement for the project: "Supply of labor, materials and equipment for the proposed multi-purpose building phase 3 in Barangay East Poblacion, City of Naga, Cebu;"

WHEREAS, the City Government has accepted the offer of E.C. Manubag Builders for the execution and completion of the above-stated project and remedying any defects therein in the amount of P4,397,760.02.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Contract of Agreement with E.C. Manubag Builders for the proposed multi-purpose building phase 3 (Contiguous Contract) in Barangay East Poblacion, City of Naga, Cebu in the amount of Four Million Three Hundred Ninety-Seven Thousand Seven Hundred Sixty Pesos and 02/100 (P4,397,760.02).
