**RESOLUTION NO. 1911-2025**

**APPROVING THE AMOUNT OF EIGHT HUNDRED SIXTY-ONE THOUSAND THREE HUNDRED THREE PESOS AND 09/100 (P861,303.09) CHARGEABLE AGAINST LUMP SUM APPROPRIATION FOR THE 2025 NATIONAL WOMEN'S MONTH CELEBRATION**

**WHEREAS**, it is the policy of the State that it "shall protect the working women by providing safe and healthful working conditions, taking into account their maternal functions, and such facilities and opportunities that will enhance their welfare and enable them to realize their full potential in the service of the nation;"

**WHEREAS**, Presidential Proclamation No. 227 series of 1988 declares the observance of the month of March as Women's Role in History Month, and Republic Act No. 6949 series of 1990 proclaims March 8 of every year as National Women's Day which aims to give recognition to the contributions of Filipino women in our society;

**WHEREAS**, subjected to deliberation is the request for funding allocation totaling P861,303.09 to cover the expenditures of the 2025 Women's Month-Long Celebration which include among others, the procurement of t-shirts, tarpaulins, theme decorations for three (3) days, LED wall, lights and sound system, meals and snacks, cash prizes for Ginang ng Tahanan 2025, office supplies and honorarium for resource speakers.


