RESOLUTION NO. 1912-2025

APPROVING THE SPECIAL PROGRAM IN THE ARTS GRAND RECITAL CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF TWO HUNDRED FIFTEEN THOUSAND FIVE HUNDRED PESOS (₱215,500.00)

WHEREAS, the school's Special Program in the Arts (SPA) curriculum at City of Naga Integrated Center for Science Technology Culture and Arts has organized an annual recital which showcases the artistic abilities of students who have been trained in various disciplines such as dance, music, visual arts, media arts, creative writing, and theater arts throughout the school year;

WHEREAS, the Office of the City General Services Officer has requested this Sanggunian for funding allocation to cover the cost for the holding of the SPA Grand Recital, which includes, among others, the honorarium for Symphony Orchestra with Strings and Winds, honorarium for Orchestra Arranger (three [3] songs per Arranger), honorarium for Orchestra Conductor, meals and snacks, and other related expenses;

WHEREAS, this Sanggunian, in a session duly assembled, deemed it appropriate to grant the request for funding allocation to ensure the success of the said activity and achieve the goal of the special program for the benefits of the students.
