RESOLUTION NO. 1915-2025

APPROVING THE PROPOSED CONSTRUCTION OF A ONE HUNDRED (100)-FOOT DEEP WELL AT HOUSING, BARANGAY INOBURAN, CITY OF NAGA, CEBU CHARGEABLE AGAINST LUMP SUM APPROPRIATION AMOUNTING TO ONE HUNDRED FIFTY THOUSAND PESOS (₱150,000.00)

WHEREAS, Engr. Joveno C. Garcia, City Planning and Development Coordinator, requested this Sanggunian for the passage of a resolution approving the funds for the proposed construction of a 100-foot deep well at Housing, Barangay Inoburan, City of Naga, Cebu, with details specified below:

- LUMP SUM APPROPRIATION 20% DEV. FUND 2024 SOCIAL DEVELOPMENT (CONST. & REHAB. OF DEEP WELLS & SPRING DEVELOPMENT)
 - Proposed Construction of a 100-foot Deep Well, Housing, Barangay Inoburan, City of Naga, Cebu

Fund 2024 - Social Development (Construction and Rehabilitation of Deep Wells & Spring Development) in the amount of One Hundred Fifty Thousand Pesos (₱150,000.00).
