APPROVING THE PROCUREMENT OF 1ST QUARTER COMMON-USE SUPPLIES FOR MUSEO NAGA (2025) CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF TWENTY-THREE THOUSAND TWO HUNDRED SIX PESOS AND 61/100 (P23,206.61)

WHEREAS, subjected to deliberation is the request of Ms. Ruth Rowena B. Alensonorin, City Information and Community Relations Officer – Tourism and Heritage Development Officer – Designate, for approval of the procurement of 1st quarter common-use supplies for Museo Naga (2025), the city's public museum located on the second floor of the Legislative Building in Barangay East Poblacion, City of Naga, Cebu;

WHEREAS, the Museo Naga has been established to provide a platform where the Nagahanons and the visiting public may appreciate the city's history, heritage, environment and its adaptation through time;
