

## **RESOLUTION NO. 1919-2025**

WAIVING ALL CIVIL REGISTRY FEES AS STATED IN THE REVENUE CODE OF THE CITY OF NAGA, CEBU, PARTICULARLY ARTICLE 2 LOCAL CIVIL REGISTRY FEES - SECTION 192 AS SUPPORT FOR THE ATI COMMUNITY AND OTHER INDIGENOUS PEOPLE IN THE CITY OF NAGA, CEBU

WHEREAS, the City Government of Naga, Cebu has been very supportive of the indigenous people particularly the ATI Community in Barangay South Poblacion, who were chosen as beneficiaries by private, public and non-government organizations during various outreach program activities;

WHEREAS, Ms. Angelita C. Generale, City Civil Registrar, cited one of the challenges encountered during mobile registration in the ATI Community which is the difficulty in complying with the basic mandatory requirements such as the negative certification, marriage and death certificates and affidavits due to their incapacity to pay the fees imposed on the aforementioned issuances:

WHEREAS, in a letter dated February 20, 2025, Ms. Generale requested for the passage of a resolution waiving all civil registry fees as stated in the Revenue Code of the City of Naga, Cebu, particularly Article 2 Local Civil Registry Fees - Section 192 to fully support the ATI Community and other indigenous groups in the city.

NOW THEREFORE, on motion of Hon. Carmelino N. Cruz, Jr., seconded en masse, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to waive all civil registry fees as stated in the Revenue Code of the City of Naga, Cebu, particularly Article 2 Local Civil Registry Fees - Section 192 as support for the ATI Community and other indigenous people in the City of Naga, Cebu.
