RESOLUTION NO. 1922-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A CONTRACT OF SERVICE WITH MR. NESTOR B. ALFORNON, A BASEBALL TRAINER, AS ENDORSED BY THE LOCAL SCHOOL BOARD FOR THE PERIOD FEBRUARY TO DECEMBER 31, 2025 WITH A MONTHLY HONORARIUM OF TEN THOUSAND PESOS (₱10,000.00)

WHEREAS, the Department of Education (DepEd) City of Naga Schools Division Superintendent has endorsed to the Local School Board the hiring of a trainor to train baseball to the student-athletes;

WHEREAS, Mr. Nestor B. Alfornon, a resident of Center 2, Tangke 1, City of Naga, Cebu, has the knowledge, necessary skills and experience to conduct baseball training for the athletes in accordance with the timetable, procedures and system approved by the DepEd - City of Naga Schools Division Superintendent;

WHEREAS, the Local School Board, through Resolution No. 013-2025, has resolved to approve the request for the hiring of a trainor for baseball with a monthly honorarium of Ten Thousand Pesos (₱10,000.00) chargeable against the Special Education Fund (SEF) 2025 -Honoraria:

WHEREAS, the City Government responded positively to the recommendation and the contract of service of Mr. Yu which will take effect upon signing until December 31, 2025 subject for renewal upon satisfactory recommendation by the DepEd-City of Naga Schools Division.

NOW THEREFORE, on motion of Hon. Clint Isidro A. Chiong, seconded by Hon. Faith James B. Servano, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Contract of Service with Mr. Nestor B. Alfornon, a baseball trainer, as endorsed by the Local School Board for the period February to December 31, 2025 with a monthly honorarium of Ten Thousand Pesos (₱10,000.00).
