RESOLUTION NO. 1931-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A STUDENT INTERNSHIP CONTRACT WITH UNIVERSITY OF CEBU (UC) FOR THE LATTER'S STUDENT INTERNSHIP PROGRAM OF COLLEGE STUDENTS IN THIS LOCAL GOVERNMENT UNIT (LGU) FOR A MINIMUM OF THREE HUNDRED (300) HOURS

WHEREAS, subjected to deliberation is the request of the City Legal Officer, Atty. Jessica B. Natad for the passage of a resolution authorizing the Honorable City Mayor Valdemar M. Chiong to sign a Student Internship Program with UC, a higher educational institution, in relation to the latter's internship program for college students;

WHEREAS, the internship program will provide the students the opportunity to undergo actual work setting at LGU-City of Naga, Cebu, being the host training establishment, strengthen their career guidance and apply their acquired knowledge and skills from formal education to actual job;

WHEREAS, the City Government and UC will forge a collaboration and linkage with each other through the proposed Student Internship Program in order to effectively implement this program in support of the educational environment of the student interns.

WHEREAS, this Sanggunian recognizes the importance of this internship which provides the student interns to experience actual work setting at the LGU-City of Naga for a minimum of 300 hours, and develop competencies pursuant to the academic goals and industry standards.

NOW THEREFORE, on motion of Hon. Clint Isidro A. Chiong, seconded by Hon. Carmelino N. Cruz, Jr., for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Student Internship Contract with UC for the latter's Student Internship Program of college students in this LGU for a minimum of three hundred (300) hours.
