AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A MEMORANDUM OF AGREEMENT (MOA) WITH CEBU TECHNOLOGICAL UNIVERSITY (CTU) FOR THE ON-THE-JOB TRAINING (OJT) OF THE LATTER'S STUDENTS FOR ACADEMIC YEAR 2024-2025

WHEREAS, the City Government is committed to support the academic and professional growth of students by providing a conducive environment for hands-on learning experiences within its organizational setting;

WHEREAS, the Office of the City Legal Officer, in a letter dated March 07, 2025, favorably endorsed to this Sanggunian the approval of the proposed MOA with Cebu Technological University, an educational institution with office address at R. Palma Street, Cebu City, relative to the OJT of the latter's students;

WHEREAS, CTU recognizes the importance of practical training and on-the-job learning to supplement academic instruction and prepare students for professional and public service;

WHEREAS, this Sanggunian finds merit in establishing a partnership with CTU to pursue this program, as this will expose students to actual or real-life experience in the workplace.
